**Dr. Frederick A Sprague**

At Eagle, on the 4<sup>th</sup> of February 1864 after a lingering illness, Dr. Frederick A. Sprague, in the 70<sup>th</sup> year of his age.

Dr. Sprague was a native of Massachusetts, emigrated to Ohio, in early life, thence in 1842 to the young territory of Wisconsin, locating at Eagle, where he resided until his death. He was for many years one of the most successful physicians in the State. In 1848 he was chosen a member of the State Senate for Waukesha County, and served his constituents faithfully in that capacity. He was a noble generous and true hearted man, and his loss will be deeply felt by a large circle of friends and relatives.

Dr. Sprague had been for many years a member of the Masonic Fraternity. His funeral was largely attended on Sunday, and was conducted with solemn and impressive Masonic ceremonies, the members of Rob Morris Lodge, in a body following his remains to the grave.
