## Eagle Pioneer Resident Dies

EAGLE — A pioneer resident of Eagle, Alice Baker, 91, died Monday at the Sauk County Health Care Center, Reedsburg, where she has lived for a year.

Miss Baker was a teacher most of her life, having started in 1910 after attending Whitewater Normal School. In the early years she taught in Montana, Lancaster and Eau Claire.

In 1934 Miss Baker visited her brother John Earl Baker in China and taught for two years in Peking. On returning home, she taught at Eagleville and Wales, ending her career in 1945 in Shullsburg.

Miss Baker was a member of the Waukesha Writers' Club and the Waukesha County Historical Society, having contributed many articlas to the society's publication "Landmark." She was also a member of the Eagle United Methodist Church and wrote the history of the church for its centennial in 1971.

She is survived by her sister Mrs. Aurel Pardee, who is also at the Sauk County Health Care Center.

Funeral services will be Thursday at 2 p.m. at the Eagle United Methodist Church, with burial in the Little Prairie Cemetery.

The body will lie in state after 4 p.m. today at the Mealy Funeral Home.
