Carrollton, Texas - David M. Kalnes, age 37, of Carrollton, Texas, formerly of Eagle, died Mon., Apr. 24, in the Chuska Mountains near the Arizona-New Mexico border. The airplane on which he was traveling with three other people was discovered on Sat., Aug. 19.

He was born June 27, 1957, in Madison to Rasmus B.A. and Donna M. (Simondet) Kalnes. He married Leslie Marie Hubbard on May 30, 1981, in Batavia, Ill. He was the chief financial officer and legal counsel for Univesco Inc., an Addison, Texas, property management company. He was a member of St. Paul Lutheran Church, Farmers Branch, Texas.

He graduated from Palmyra-Eagle High School in May, 1975. His many achievements included his selection as the Outstanding Teenager of Wisconsin 1974 and Waukesha County Farm Bureau's Young Farmer, and was listed in Who's Who and the Society of Outstanding American High School Students.

He graduated from Luther College, Decorah, Iowa, in May 1979, with a B.A. in the Classics: Greek, Latin and Philosophy. He was a member of Nordic Choir. He received his Juris Doctor Degree in Law from Valparaiso University, Valparaiso, Ind., in May 1982.

He is survived by his wife, Leslie; and his children, Anna Elizabeth and

Erik David. He is further survived by his parents, Rasmus and Donna Kalnes, Eagle; and his sister, Stephanie of Milwaukee; and brother, Eric, of Huntington Beach, Cal. He is also survived by his father-in-law and mother-in-law, Paul and Mary Ann Hubbard of Batavia, Ill; brothers-in-law, Tom (Carol) of Racine; Robert (Kathy), Richard (Barbara), and Douglas (Jean) of Batavia, Ill.
