

is hereby acknowledged, the following tracts of land, situate in the town of Eagle, in the County of Waukesha, and State of Wisconsin, to-wit: Lot 150 in Block Oak Ridge Cemetery, according to the recorded plot thereof as recorded in the office of the Register of Deeds of Waukesha County, Wisconsin; provided, that this conveyance is made upon the following conditions, limitations and restrictions:

First. This conveyance is made expressly for burial purposes, and no other.

Second. No trees, shrubs, vines, plants, fences, head stones, monuments or other structures shall be planted, erected or maintained on said lot, or removed therefrom, or disturbed, re-arranged, injured or destroyed, except by permission or under the direction of the Board of Trustees of said Association, nor shall any lot be graded or re-graded except with like permission and direction, and any tree, shrub, plant, vine, fences, structures, monuments or head stones now upon, or which may hereafter be placed or erected upon said lot, may be ordered by the governing board of said Association to be removed, re-arranged, rebuilt or repaired, and said board may require said lot to be graded or re-graded, and cause same to be done upon notice made in accordance with the provisions of Section 1453 of the Revised Statutes of Wisconsin for 1878.
