MARY FRANCIS BERG of Springfield, Missouri, MR. JOHN E. CLOHISY of Chicago, Illinios, MR. THOMAS M. CLOHISY of Fairfox Station, Virginia, MRS PATRICIA ROULEAU of Fairfax, Virginia.

If any of these persons shall predecease me, his share shall go to those persons who would have been his heirs-at-law if he had died at the date of my death. I further direct that before the property shall be divided in the percentages given above, the above recipients shall have the right to divide all personal and household articles owned by me at the time of my death among themselves as they see fit. This shall apply only to personal items owned by me not having any substitive market value.
