Any emergency meeting could be called by the Fastor or Administrative Foard chairperson. The Parish treasurer will now give the monthly financial reports to the tree church teasurers, Administrative Board chairpersons, the Pastor and FPRC chairperson. The Administrative Foard chairperson will chair the meeting held at his or her church building.
